TOWNSHIP OF MACHAR MINUTES – REGULAR MEETING Monday, January 10, 2022

Call to Order, Disclosures of Pecuniary Interest and the General Nature Thereof; nil.

The Province has moved to a modified Step 2 in response to the Covid-10 Omicron variant. The restrictions take effect on Wed, Jan 5, 2022 and last until at least Jan 26, 2022 subject to the status of public health indicators. Businesses and organizations are required to ensure that their employees work remotely unless the nature of their work requires them to be on site. Other restrictions include social gathering limits will be reduced to 5 people indoors and 10 people outdoors, organized public events will be limited to 5 people indoors... As such, the meeting was held by teleconference.

BUSINESS

1. Minor Variance 3/21 – Pt Lot 28, Con 7, 315 Scarlett Rd

Staff Report dated Jan 10, 2022 received and reviewed. Concerns put forward and addressed; development agreement to prohibit site alteration and vegetation removal within 20 m of the shoreline on the subject property, other than for a pathway to access the shoreline and existing dock. Hazardous trees may be removed. Photographs taken during the site visit and will serve to document the existing vegetation. They can be included in the development agreement. The $\,$ agreement will contain additional provisions with respect to the hazardous trees and can include conditions to consult the municipality, the hazardous trees be photographed and reported. A travel trailer has been present on the subject property. A travel trailer can be located and used on a lot in the SR Zone for no more than 30 days in a calendar year. A travel trailer is not permitted to be used on the subject property during the construction of the new dwelling. Planner for the owner indicated the owner will remove the travel trailer as soon as weather permits in the Spring. A municipal zoning compliance will be required prior to the issuance of any building permits to ensure the trailer has been removed. The proposed application is to permit a single detached dwelling with a minimum front yard of 13 m where 23 m is required. The original shore road allowance is not purchased and therefore the minimum front yard is measured from the lot line abutting crown shoreline reserve (original shore road allowance). The proposed dwelling is to be located a minimum of 33 m from the high water mark. Due to the original shore road allowance not being purchased, the front lot line is considered the inner limit of the shore road allowance. Although the above variance is required, the proposed single detached dwelling meets the minimum setback from Eagle Lake (33 m where 23 m is required). Decision: Granted with conditions.

Conditions: That the owners enter into a Development Agreement or Site Plan Agreement: to prohibit site alteration and vegetation removal within 20 m of the shoreline, other than for a pathway to access the shoreline and existing dock, to install sediment and erosion control measures during the construction of the dwelling and septic system to prevent erosion and runoff into the shoreline area. Hazardous trees may be removed. A zoning compliance review be undertaken prior to the issuance of any building permits. Reasons for Decision: Is in keeping with the intent of the Official Plan and Zoning By-Law, is desirable for the appropriate development of the lands, is minor in nature, represents good planning. Members Lynda Carleton and Ron McLaren signed the decision in person. Members Blair Flowers and Neil Scarlett signed digitally. Member Bart Wood didn't sign. Notice of Decision will be sent out tomorrow. Appeal period is 20 days.

Minor Variance 4/21 - Plan 196, Lot 5, Hawthorne Dr

a. Almaguin Community Hatchery Program

Reviewed and discussed. ACHP extends an invite to help fund their quest in restoring our Walleye population, presently within the Magnetawan River System of the Almaguin area by purchasing and installing new educational data monitoring components. They presently have 2 micro hatcheries in Almaguin, 1 in the Magnetawan Public School and 1 in the Almaguin Highlands Secondary School. They need to purchase high tech equipment to monitor in real time, water levels, water flow rates, oxygen levels, PH levels, ammonia levels, temperatures, all via sensors, camera, computer equipment and software programs. Their hatchery has the capability of being able to hatch close to 5 million fry with limited manpower. Their mobile hatchery is simple, sophisticated and modern. \$500 donation will help them reach their goal of \$10,000 to proceed with the educational component in their mobile hatchery because we can make a difference. Approved \$500.

10. FONOM; Ontario Advances Critical Road Infrastructure in the North, making Northern Highway's safer, Prov seeking input on 2+1 hwy pilot to improve road safety and support economic growth

The Ontario government is taking steps to help improve road safety and traffic flow in Northern Ontario with a 2+1 highway pilot on Hwy 11 north of North Bay. The 3 lane highway with a centre passing lane that changes direction approximately every 2 to 5 km is part of the government's plan to build Ontario, it's the 1st ever 2+1 highway pilot in North America to help make our roads safer. The province has identified the 2 top locations for the proposed pilot; Hwy 11 from Sand Dam Rd to Ellesmere Rd (14 km), Hwy 11 from Hwy 64 to Jumping Caribou Lake Rd (16 km). Public and stakeholders can comment on the proposed pilot locations on the Ministry of Transportation's Technical Consultation Portal until Jan 11, 2022. The province will evaluate comments and announce the final pilot locations to advance to preliminary design in Jan 2022.
